## **INFORMATION REQUEST REFERENCE 21-012**

## Dear

Thank you for your information request, received on 7 April 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA) / Environmental Information Regulations 2004 (EIR):

*"Please can you provide me with all emails and documentation relating to the planning application process that was submitted for residential dwelling at 419 Wick Lane, London, E3 2PX.* 

- This includes all internal and external comms between the LLDC and applicants."

Due to the number of planning applications in relation to this property, this request was clarified to *"mean the application that related to this property being repurposed from live-work units to being used for purely residential purposes."* 

The reference for this application was identified as 12/00165/FUM; decided on 19 December 2012, with Victoria Crosby as the planning officer.

I can confirm that the Legacy Corporation holds information which falls within the scope of your request.

There is documentation available on the planning register under the planning reference 12/00165/FUM. In addition, **Annex A** contains all the emails identified as relevant to this planning application.

Please be advised that information has been redacted under EIR regulation 13 – personal data.

## EIR Reg 13 - personal data

 (1) To the extent that the information requested includes personal data of which the applicant is not the data subject, a public authority must not disclose the personal data if— (a) the first condition is satisfied, or

(b) the second or third condition is satisfied and, in all the circumstances of the case, the public interest in not disclosing the information outweighs the public interest in disclosing it.

## (2A) The first condition is that the disclosure of the information to a member of the public otherwise than under these Regulations— (a) would contravene any of the data protection principles

It is the standard practice of the Legacy Corporation to redact personal information for those members of staff under Head of Service level, and for non-Legacy Corporation personnel unless consent to release the information has been received and the information is not already in the public domain. In this instance, the relevant condition that applies is Regulation 13(1)(a), whereby the information is defined as personal data within Section 3(2) of the Data Protection Act 2018.

**Annex B** identifies where information was part of the correspondence, but is already public or has been removed as it is not relevant to the request.

- Any email attachments relevant to your request have been inserted behind the specific email.
- Email attachments have not been included where these are already in the public domain.
