Thank you for your information request, received on 6 August 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I am requesting information in relation to the LLDC participating in the Transport for London (TfL) lead trial of E-scooters.

Please can you provide the below data;

- 1) Has the LLDC expressed interest or is actively considering joining the E-scooter trial as a ride-through only area (no parking bays provided but e-scooters can ride through the park)?
- 2) Has the LLDC expressed interest or is actively considering joining the E-scooter trial by partial participation (with a selected portion of the park taking part in the trial) 2
- 3) Has the LLDC expressed interest or is actively considering joining the E-scooter trial by full participation (permission to travel across the whole park region with parking bays provided for e-scooters)?
- 4) Has the LLDC investigated possible locations for e-scooter parking bays? If yes please provide a list of locations.
- 5) At which phase or month of the TfL trial is the LLDC expected to join?"

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below. Our response follows your order:

Q1. Has the LLDC expressed interest or is actively considering joining the E-scooter trial as a ride-through only area (no parking bays provided but e-scooters can ride through the park)?

Transport for London (TfL) has approached us about the opportunity and are interested in us taking part. Details are yet to be discussed and the Legacy Corporation is waiting for a proposal from TfL.

Q2. Has the LLDC expressed interest or is actively considering joining the E-scooter trial by partial participation (with a selected portion of the park taking part in the trial)?

Please see the response to Q1 above.

Q3. Has the LLDC expressed interest or is actively considering joining the E-scooter trial by full participation (permission to travel across the whole park region with parking bays provided for e-scooters)?

Q4. Has the LLDC investigated possible locations for e-scooter parking bays? If yes please provide a list of locations.
