**INFORMATION REQUEST REFERENCE 21-030**

Thank you for your information request, received on 11 October 2021. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

*"I would like all information held referring to me or my property. In particular, I would like a copy of the report LLDC received from LendLease on noise and vibrations levels in my property [Lantana Heights, Glasshouse Gardens, Stratford, E20 1HR]."*

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. Please find attached in **Annex A**, the Ground Borne Rail Noise report for Lantana Heights. The client is Stratford City Business District, however, Lendlease were part of SCBD.

Please be advised that information has been redacted under FOIA section 40 – personal information.

Section 40(2) – personal information

*(2) Any information to which a request for information relates is also exempt information if –  
(a) it constitutes personal data which does not fall within subsection (1), and  
(b) the first, second or third condition below is satisfied.*

It is the standard practice of the Legacy Corporation to redact personal information for those members of staff under Head of Service level, and for non-Legacy Corporation personnel unless consent to release the information has been received.

The section 40 exemption is absolute and is not subject to the public interest test. In this instance, the relevant condition that applies is section 40(2) whereby the information is defined as personal data within s.3(2) of the Data Protection Act 2018.

Please note: your request for your personal information is being provided separately as a subject access request.
