INFORMATION REQUEST REFERENCE 22-015

Thank you for your information request, received on 20 June 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"Please provide information regarding the total cost to the public to date of restoring, upgrading and maintaining the facilities and spaces in the Olympic Park, including the renovation of the Athletes' Village which is not in the Park, since the end of the Games after the Paralympic Games.

I would also request a breakdown per facility and the spaces."

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below:

Transformation

All costs related to Transformation were provided in our previous response reference 18-077. There has been no change to the figures since this response. The previous response has been attached in **Annex A** for reference.

Maintenance

Maintenance costs as previously provided and for 2018/19, 2019/20 and 2020/21 are in our Annual Report and Accounts which are publicly available. Therefore, we are refusing this aspect of the request under FOIA section 21 - Information accessible to applicant by other means.

<u>FOIA Section 21 - Information accessible to applicant by other means.</u>
(1) Information which is reasonably accessible to the applicant

The maintenance costs up to 2020/21 are in the public domain including published on the Legacy Corporation website.

The figures for 2021/22 will be published in the annual accounts and are being withheld under FOIA Section 22 – Information intended for future publication.

FOIA Section 22 - Information intended for future publication.

(1) Information is exempt information if—

- (a) the information is held by the public authority with a view to its publication, by the authority or any other person, at some future date (whether determined or not), (b) the information was already held with a view to such publication at the time when the

- (c) it is reasonable in all the circumstances that the information should be withheld from disclosure until the date referred to in paragraph (a).

The Annual Report and Accounts are published annually and will be available on our website.

Upgrades

The Legacy Corporation holds the following information in relation to upgrade costs, from 2016/17 onwards.

Please note: as previously mentioned in our 18-077 response, the Legacy Corporation does not hold cost information in relation to the original build, transformation or maintenance of the Athletes Village. While the Athletes Village is within the Legacy Corporation Planning area, the Legacy Corporation has had no responsibility for the design, development, operation or maintenance of Athlete's village. The Olympic Delivery Authority (ODA) managed the reconfiguration and disposal of the village post-Games. On closure the ODA information was transferred to the Department of Digital, Culture, Media and Sport (DCMS).
