

## **INFORMATION REQUEST REFERENCE 22-019**

Thank you for your information request, received on 20 June 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

This is a request under the Freedom of Information Act 2000. I would like to request the following information:

- How many paid staff work at/for the LLDC as of 2022 (or 2021 if information not available).

- The number or percentage of all paid staff at the LLDC (full-time and part-time) that currently live in the London Borough of Newham.

- The number or percentage of paid staff (full-time and part-time) that were previously unemployed before working at the LLDC.

- The number of all paid staff (full-time and part-time) that are female, BAME, and/or disabled.

If anything is unclear, please let me know as soon as possible so that I may be able to clarify my request.

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below and our response follows your order:

## Q1. How many paid staff work at/for the LLDC as of 2022 (or 2021 if information not available)?

As at 20th June 2022, the Legacy Corporation have a headcount of 185 staff.

Q2. The number or percentage of all paid staff at the LLDC (full-time and part-time) that currently live in the London Borough of Newham.

As of 20<sup>th</sup> June 2022, 6% of all directly employed staff live in the London Borough of Newham.

Q3. The number or percentage of paid staff (full-time and part-time) that were previously unemployed before working at the LLDC.

The Legacy Corporation does not hold this information.

Q4. The number of all paid staff (full-time and part-time) that are female, BAME, and/or disabled.

As of 20<sup>th</sup> June 2022, of all paid staff, 58% are Female, 30% are Black, Asian or Minority Ethnic and 9% have a declared disability.
