INFORMATION REQUEST REFERENCE 22-020

Thank you for your information request, received on 20 June 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I am requesting the following information:

- To date (2022, or 2021) how many, or what percentage, of the 11,500 homes that have been built on the area overseen by the LLDC, can be accurately described as 'affordable housing'? Definitions of affordable housing being 'social rented housing', 'immediate housing for sale' or 'immediate housing for rent'. "

The Legacy Corporation in its role as Local Planning Authority publishes an Annual Monitoring Report (AMR) which provide the latest information on housing permissions and housing completions each year and this includes information on the amount of affordable housing that this includes. The last AMR was published in July 2021 and can be viewed and downloaded from the Legacy Corporation website here amr-2020-21_22-july-21.ashx (queenelizabetholympicpark.co.uk). The most relevant tables are Table 21 (page 59) Affordable Housing Permitted since 2014, and Table 23 (page 63) Affordable Housing Completed Since 2014. The next AMR is due to be published at the end of July 2022 and will include updated information and some additional detail to that previously published.

It should be noted that the definition of affordable housing used in recording and reporting this data is consistent with the National Planning Policy Framework and within those definitions also includes the definitions give in the London Plan, for example the 'Affordable Rent' category includes Social Rent and London Affordable Rent.
