## **INFORMATION REQUEST REFERENCE 22-022**

Thank you for your information request, received on 4 July 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"This is a request for information under the Freedom of Information Act 2000.

In a previous request to the LLDC (Ref Number 22-019) I asked for the total number of employed staff at the LLDC who lived in the London Borough of Newham. I received this information on June 29th 2022 (I have attached the PDF response below).

The response stated that 6% of all 185 directly employed staff at the LLDC lived in the London Borough of Newham. This amounts to 11 (or 11.1 to be exact) full-time staff at the LLDC who live in Newham.

After receiving the response to my request, I am requesting the following information:

- The position names of the 11 (or 12, accounting for the 6% calculation) staff that have a registered address in Newham, and the directorate they are under.

- The number of salaries of the 11 (or 12, accounting for the 6% calculation) Newham-based staff that are above £50,000. This is in accordance with the LLDC's practice of publishing staff salaries above £50,000 as found <u>here.</u> "

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below:

The Legacy Corporation Newham-based colleagues are in a mix of Directorates:

- Park Operations & Venues;
- Communication, Marketing and Strategy;
- Executive Office;
- Development;
- Regeneration and Community Partnerships, and
- Planning Policy and Decisions Team (PPDT).

Of these Newham based colleagues, 64% have salaries in excess of £50k.

Please note further, more detailed information in relation to position names is being withheld under FOIA section 40(2) – personal information.

## Section 40(2) – personal information

(2) Any information to which a request for information relates is also exempt information if –
(a) it constitutes personal data which does not fall within subsection (1), and
(b) the first, second or third condition below is satisfied.

(3A) The first condition is that the disclosure of the information to a member of the public otherwise than under this Act—

(a)would contravene any of the data protection principles,

Individuals may be identifiable from the position names in combination with other information already in the public domain. In addition, their private address information, including the borough they live in, was collected specifically in relation to their employment and was not provided with the expectation that any of it would be made public.

The section 40 exemption is absolute and is not subject to the public interest test. In this instance, the relevant condition that applies is section 40(2) whereby the information is defined as personal data within s.3(2) of the Data Protection Act 2018.
