## **INFORMATION REQUEST REFERENCE 22-024**

Thank you for your information request, received on 25 July 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I would like to make a freedom of information request in regards to the planning appeal lodged for 94-111 Leabank Square. In the first instance would it be possible to provide a summary of the submission and representations?

The request was clarified on 2 August 2022 as: I would like confirmation of your submission as the local planning authority please and when the decision is expected to be made.

In terms of representations, I would like to know the number of and which consultees have responded and the number of neighbour or consultee responses that were submitted following the appeal submittal prior to the closing deadline of 17th March 2022."

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below:

## Q1. Confirmation of the Local Planning Authority's representation and the expected date for the appeal decision

Please follow the below link to the Local Planning Authority's Statement of Case, the Local Planning Authority's completed Appeal Questionnaire with Local Plan cover, contents and relevant policies and letter to neighbours submitted as attachments with the Appeal Questionnaire is attached in **Annex A**.

The Planning Inspectorate will determine the appeal and have not provided an indication of the expected decision date. I can, however, advise that the Planning Inspectorate has published figures for S78 appeals from June 2022, indicating the mean and median weeks for decisions, measured from the time an appeal which they are able to progress ('valid') to the time a decision is issued:
