## **INFORMATION REQUEST REFERENCE 22-031**

Thank you for your information request, received on 18 August 2022. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA):

"I am requesting access to information under the Freedom of Information Act about the Three Mills Lock on the Prescott Channel on the River Lea.

Please could I have a copy of the document, written by Buro Happold for LLDC, in order for the Olympic Park to get through the Water Flood Defences impact assessment, which listed what studies were necessary to assess the impact of the Three Mills Lock."

The request was clarified with the following additional information:

## "I believe that:

- the date of the document was likely 2014 and,
- the name was something like Olympic Park Water Framework Directive Assessment."

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. Please find attached in Annex A: Buro Happold report: Queen Elizabeth Olympic Park Water Framework Directive Assessment, dated 31 March 2014.

Please be advised that information has been redacted under FOIA section 40 – personal information.

## Section 40(2) –personal information

- (2) Any information to which a request for information relates is also exempt information if -
- (a) it constitutes personal data which does not fall within subsection (1), and
- (b) the first, second or third condition below is satisfied.

It is the standard practice of the Legacy Corporation to redact personal information for those members of staff under Head of Service level, and for non-Legacy Corporation personnel unless consent to release the information has been received.

The section 40 exemption is absolute and is not subject to the public interest test. In this instance, the relevant condition that applies is section 40(2) whereby the information is defined as personal data within s.3(2) of the Data Protection Act 2018.
