## **INFORMATION REQUEST REFERENCE 23-006**

Thank you for your information request, received on 14 February 2023. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

"I am writing to request information under the Freedom of Information Act 2000. Specifically, I would like to request a copy of all daylight sunlight and rights of light reports commissioned by or undertaken on behalf of your council for all sites since 1st January 2020, as well as the current development status of each site.

If any of the information contained within the reports is considered confidential or exempt from disclosure, please redact that information as necessary."

<u>The request was clarified</u>: Is the information you're requesting in relation to reviews of sunlight/daylight assessments undertaken in support of planning applications submitted to the LLDC as Planning Authority or for work undertaken on behalf of LLDC Development as applicant for planning applications, or both?

I initially wanted those undertaken on behalf of LLDC Development as applicant for planning applications but if both can be provided within the time allowed to work on this that'd be great."

I can confirm that the Legacy Corporation holds information which falls within the scope of your request, however, daylight, sunlight, and overshadowing (DSO) reports, when submitted in support of a planning application, are publicly available documents.

For LLDC-owned sites these can be found on the Legacy Corporation Planning Register which can be found at: LLDC Planning Register.

The following LLDC-owned sites have submitted planning applications which included DSO reports since 2020, with additional details provided as requested.
