## **INFORMATION REQUEST REFERENCE 23-008**

Thank you for your information request, received on 16 February 2023. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA:

My freedom of information request to LS185/E20/LLDC is to request the following:

- 1) Has LLDC CEO Lyn Garner approached, been in communication or met virtually or in person with Daniel Kretinsky?
- 2) If Yes to 1 can you provide copies of emails or letters and/or dates of meetings between Lyn Garner and Daniel Kretinsky?
- 3) If No to 1 has anyone employed by LLDC/E20 or LS185 approached, been in communication or met with Daniel Kretinsky or any of his representatives or his company EPH?
- 4) If yes to number 3 can you provide copies of emails or letters and/or dates of meetings LLDC/E20 or LS185 and Daniel Kretinsky or any of his representatives or his company EPH?"

I can confirm that the Legacy Corporation holds information which falls within the scope of your request. The information relevant to your request is below and our response follows your order:

Q1) Has LLDC CEO Lyn Garner approached, been in communication or met virtually or in person with Daniel Kretinsky?

Q2) If Yes to 1 can you provide copies of emails or letters and/or dates of meetings between Lvn Garner and Daniel Kretinsky?

Q3) If No to 1 has anyone employed by LLDC/E20 or LS185 approached, been in communication or met with Daniel Kretinsky or any of his representatives or his company EPH?

Lord Hendy met with Daniel Kretinsky by way of introduction shortly after he purchased an interest in WHU on 15 February 2022. Lord Hendy and Lyn Garner met with Peter Mitka on 27 May 2022 to introduce him to Queen Elizabeth Olympic Park.

Q4) If yes to number 3 can you provide copies of emails or letters and/or dates of meetings LLDC/E20 or LS185 and Daniel Kretinsky or any of his representatives or his company EPH?"

See Q3 for the information on the meeting dates. The Legacy Corporation does not hold any emails in relation to these meetings.
