INFORMATION REQUEST REFERENCE 23-023

Thank you for your information request, received on 25 July 2023. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Environmental Information Regulations 2004 (EIR):

"I have been looking for a copy of some policy documents/ data related to flooding and haven't been able to find some of them on your website. Could you please point me in the right direction, or provide me with copies of the following for a flood risk study:

- GIS files (shapefiles or similar) of areas with critical drainage problems, local flood risk zones (flood zone 3a,3b) as define by either the SWMP or SFRA or other measures.
- Updated/ available current and previous reports and appendices of:
 - SWMP (Surface water management plan) or similar.
 - SFRA (Strategic flood risk/ Consequence assessment),
 - PFRA (preliminary flood risk assessment).
 - LFRMS (Local Flood risk strategy).
- 3. Copies of any Supplementary Planning Documents/ Guidance with regards to flood risk, drainage and climate change.
- 4. A copy of your flood risk assessment criteria if you have one."

The Legacy Corporation prepared the following documents in relation to flood risk as part of its Local Plan evidence base and each of these can be found on the Legacy Corporation website. The approach taken relied on the most recent iterations of each boroughs Strategic Flood Risk Assessment and any other available information such as that for Critical Drainage Areas and therefore the Legacy Corporation does not hold this information. The relevant GIS data held is that provided by the Environment Agency and no other GIS flood risk related information is held.
