Thank you for your information request, received on 5 October 2023. You asked the London Legacy Development Corporation (Legacy Corporation) to provide the following information under the Freedom of Information Act 2000 (FOIA:

"Please can you provide the following information about each **planning appeal cost award or partial cost award made against your council** (including information for any now-defunct councils that have been merged into your council) by planning inspectors between 1 April 2018 and 31 March 2023:

- Date of cost award decision
- Date of appeal decision letter (if different to date of costs award decision)
- Has the amount of the cost award been determined (yes/no)?
- Amount of sum negotiated between the applicant and council for cost award (£)
- Was the decision that was the subject of the appeal made against officer recommendation (£)?
- PINS case reference number

Please could you also provide the following information about each **planning appeal cost award or partial cost award made against an applicant in your council's favour** by planning inspectors between 1 April 2018 and 31 March 2023 (please include information for any now-defunct councils that have been merged into your council):

Clarified as covering both planning applications and enforcement appeals.

I can confirm that the Legacy Corporation does not hold information which falls within the scope of your request.

The Legacy Corporation acts as the planning authority for the area around and including Queen Elizabeth Olympic Park. The Legacy Corporation has had no costs awarded to or against them for planning application appeals during the time period requested.

The Legacy Corporation has had no costs awarded to or against them for planning enforcement appeals during the time period requested.

There is one cost award in relation to an enforcement case made against an applicant in the Legacy Corporation's favour during the time period, though this was not arising from an appeal; but was awarded by the courts with respect to a prosecution; as set out below.
