Assessment of Financial Standing

Section A – Part 3A Economic and Financial Standing (Questions A69-A70) requires Tenderers (or if applicable any Relevant Company being relied upon) to provide audited accounts for the latest 2 years or 1 year if 2 years accounts are not available.

This is to make an assessment that the Tenderer can demonstrate at least two of the following minimum requirements to achieve a Pass score (Questions A71-A74):

- Cumulative operating profit (before tax) over the last two years or the latest year if only one years accounts are available;
- Cumulative net profit (after tax) over the last two years or the latest year if only one years accounts are available;
- Positive net assets in the most recent year;
- An annual average turnover of at least £24,000 in the last two consecutive years accounts or the latest year if only one years accounts are available

Your Tender submission confirmed that has no trading history and therefore financial accounts were not provided.
