- **Your Role**
  - *Briefly, what is your role in the partnership and in managing or overseeing this venue since the Olympics?*
- **PPP Arrangement**
  - *Which PPP model was chosen here (e.g., concession, joint venture), and what was the main motivation for selecting this structure?*
- **Youth Requirements**
  - *Were there any specific requirements, targets, or clauses in the PPP contract related to youth programs or community access?*
- **Outcomes & Challenges**
  - *Since the handover, how have youth-sports participation rates changed? Can you share any quantitative figures?*

What have been the main operational challenges (e.g., maintenance funding, marketing, stakeholder alignment)?

- Have there been any unexpected successes or innovations in youth programming?

- **Balance of Financial and Social Goals**

- *Have you experienced any challenges balancing commercial/revenue needs with ensuring affordable youth access? How have these been addressed?*

- **Key Lesson for Other Cities**

- *If another city is planning a similar PPP, what is one practical recommendation you'd make to ensure positive youth outcomes?*
