- TT confirmed the Road Safety Review actions will be picked up in a separate discussion / workstream now that actions have been issued to LBTH.

## Telford Homes – Wallis Road

- SP confirmed that Telford Homes have practically completed all works at the Stone Studios (Wallis Road) site.
- TT and CS thanked and commended SP and Telford Homes for participating in the HWFI CTMG since its inception.
- CK also thanked SP for continued co-operation during construction programme, particularly when there were issues in relation to contamination, odours and nuisance.

### Balfour Beatty – bridges

- SH confirmed the installation of the handrail is the only outstanding issue to be resolved by Balfour Beatty.
- SH confirmed that until this issue is resolved, smaller cycle lanes have been installed within the bus lane area.
- TT confimfred that once handrail issue has been resolved, the Monier Road bridge will not be open to buses up to the junction with Road B until the Road B works are completed, which is anticipated in Summer / Autumn 2022
- GM queried whether Monier Road bridge will be open to buses in June 2022 as LBTH understood.

# Taylor Wimpey – 90 Monier Road

- No-one on the call.
- TT confirmed works are still on hold and no update has been provided to LLDC in relation to re-commencement of works.

#### HG Construction - Dace Road

- WM confirmed the process of handovers is still ongoing throughout the development blocks.
- WM confirmed deliveries are increasing as handover of Block E is anticipated at the end of February 2022.
- WM confirmed internals / fit out appliances are now being installed on Block E.
- WM confirmed tower crane is due to be dismantled at the end of January 2022.

- WM confirmed on-site cabins will be removed in Feberuary 2022 as site offices decant into comepleted development blocks.
- TT queried the extent of external highway works and how they will be managed going forward, particualry when space is limited and multiple vehicles arriving to the site.
- WM clarified that the external highway works are limited up until practical completion.
- TB requested TMPs and deliveries details are sent to LBTH as LBTH are expecting works and disruption to Monier Road.
- TB confirmed the information and plans related to these Monier Road would be circulutated to the group.

# HG Construction – Stour Road

- JL confirmed ground works are ongoing and then deliveries to the site are expected to decrease thereafter.
- JL confirmed scaffolding is being erected around the development blocks on site.
- SC raised the issue of a HGV blocking the entrance to the site along Smeed Road and subsequent parking on adjacent pavements.
- JL confirmed that this issue would be looked into and fed back to the group once resolved.

# Blue Jay Homes – 1 Beachy Road

- BS confirmed works have been delayed due to COVID cases somgst workforce.
- BS confirmed vehicle movements are at approximately 2-6 deliveries per day.
- BS confirmed piling works are ongoing and contamination tests are also continuing in parallel.
- BS thanked GM for liasing with LBTH in relation to the excavation licence.
- BS confirmed piling is due to be completed on the 4<sup>th</sup> Februrary and excavation works will commence after that.

#### Murphy Group – Greenway

- DS confirmed works are ongoing and weight restrictions have now been removed for HGVS and all other vehicles
- DS confirmed de-sludging works will now commence to understand the extent of sewer repair works required.

• DS queried whether emails and correspondence have been reaching the LLDC and TT. TT and LLDC confirmed that no emails had been received recently from Murphy Group.

# AOB

- *MB* queried the diversion works and issues along Monier Road need to be resolved and addressed to mitigate public safety risks.
- TT confirmed that LLDC will be continuing intermittent walk-arounds to ensure actions are implemented as required.
- CS notified the group of a planning application that has been received in realtion to the vacant site at 616 Wick Lane. TT requested a meeting with the applicant and PPDT to ensure all issues are mitigated at the planning application stage.
- TB confirmed that LBTH attended a site visit with the 616 Wick Lane applicant to ensure the footpath closure is in place for as short a period as practically possible.
- SC reminded the group of muck issues around the construction sites on Fish Island and reminded the group to jet wash and salt outside their sites, particulary during the winter months.
