**The London Legacy Development Corporation and Olympic Park Legacy Company
Transfer Scheme 2012**

The Secretary of State, in exercise of the powers conferred by section 200(1) and section 218 of the Localism Act 2011, having consulted Olympic Park Legacy Company Limited and the Mayor of London, makes this Transfer Scheme.

Interpretation

1. In this Transfer Scheme-

"the Act" means the Localism Act 2011;

"OPLC" means Olympic Park Legacy Company Limited (registered number 6900359);

"LLDC" means London Legacy Development Corporation.

Transfer date

2. The transfer date is 1 April 2012.

Transfer of property, rights and liabilities of Olympic Park Legacy Company Limited to the LLDC

3. -(1) On the transfer date, all property, rights and liabilities of OPLC, including but not limited to the items specified in sub-paragraph (2) and the contracts of employment and pension rights specified in paragraphs 9 and 10, are transferred to the LLDC.

(2) The property, rights and liabilities referred to in sub-paragraph (1) include-

- a. the property specified in Schedule 1A;
- b. the rights and liabilities under the contracts specified in Schedule 1B;
- c. the assets specified in Schedule 1C;
- d. the assets specified in Schedule 1D;
- e. the property, rights and liabilities relating to the software licences specified in Schedule 1E;
- f. the rights and liabilities relating to the agreements and memoranda of understanding specified in Schedule 1F;
- g. the property, rights and liabilities relating to the licences specified in Schedule 1G; and
- h. the rights and liabilities relating to the warranties specified in Schedule 1H.

- (3) The property rights and liabilities referred to in sub-paragraph (2)a include any leases, tenancies, licences, agreements, infrastructure agreements, easements, wayleaves, development agreements, building contracts, appointments and encumbrances on titles.

Transitional, supplementary and incidental provision

4. Anything done (or having effect as if done) before the transfer date by or in relation to the OPLC in respect of anything transferred by this scheme, has effect on and after that date as if done by or in relation to the LLDC.
5. Anything which, before the transfer date is in the process of being done by, on behalf of or in relation to the OPLC in respect of anything transferred by this scheme (including legal proceedings) may be continued on and after that date as if done by or in relation to the LLDC.
6. Any reference to the OPLC in an instrument or other document in respect of anything transferred has effect on and after the transfer date as a reference to the LLDC, including the membership or share of any company or limited liability partnership.
7. A reference in paragraphs 4 to 6 to anything transferred by this scheme, applies to any property, right or liability transferred, whether or not identified specifically in the scheme.
8. A certificate issued by the Secretary of State will be conclusive evidence that that property has transferred to the LLDC.

Transfer of posts and employees of the Olympic Park Legacy Company

- 9(1). On the transfer date, the rights and liabilities under the contracts of employment of all individuals employed by OPLC, the staff numbers of which include but are not limited to those specified in Schedule 11, are transferred to the LLDC.
- (2) The rights and liabilities referred to in 9(1) above includes assets and liabilities relating to the membership in the Local Government Pension Scheme administered by the London Pensions Fund Authority of those individuals.
