3. Planning authority's views

The planning authority welcomes the highly inventive approach taken in developing proposals for the Gantry. Planning permission was granted for modification of the Gantry in March 2014. Updated design proposals are presented to demonstrate how it is intended to comply with the planning permission.

The planning authority is more cautious about the approach to the proposed Sky Sign; this reflects the need to consider policies for the wider Queen Elizabeth Olympic Park – where there are numerous demands for signs and advertisements. The design for the Sky Sign will be subject to a separate application for advertisement consent.

4. Quality Review Panel's views

Summary

The Quality Review Panel strongly supports the innovative approach taken to provide bespoke spaces for diverse small businesses. It also thinks that the design of the proposed Sky Sign will be an appropriate addition to Here East.

The Gantry

- The Quality Review Panel is impressed by the proposal for creating individual spaces within the Gantry.
- It thinks that the use of WikiHouse an open source integrated stack building system is a novel and exciting initiative.
- This approach has the potential to provide a variety of accommodation suited to the specific needs of diverse small businesses.



Sky Sign

- The panel also thinks that the design of the Sky Sign is successful.
- The design would appear to be sensitive to the impact of an illuminated sign of this scale on future residential development to the south of Here East.
- While other structures / buildings in Queen Elizabeth Olympic Park are distinguished by their form, the simple box form of Here East can support external graphic signage.
- The panel thinks that the proposed sign, while elegant, has a strong presence and is in keeping with the spirit of Here East.

Next steps

- The panel supports the way in which emerging designs for the Gantry comply with the planning permission granted in March 2014.
- It also supports approval of advertisement consent for the Sky Sign.
