3. Planning authority's views

The new Hackney Wick Station is central to the Hackney Wick Strategic Masterplan for a new Neighbourhood Centre. In addition to achieving improved connectivity, in particular by creating a new north/south route, the scheme aims to achieve a distinctive and innovative design that will contribute to a strong and individual identity for Hackney Wick.

4. Quality Review Panel's views

Summary

The Quality Review Panel is pleased to support the planning application for Hackney Wick Station for approval. The one aspect of the design which the panel feels would benefit from further thought, is the public realm. It will also be essential that the quality of the station architecture promised by the application is followed through with high quality materials and construction. These comments are discussed further below.

Public Realm

- The panel welcomes the extension of the brief for the station to include the public realm both to the north and south of the station.
- Some elements of the landscape design will be temporary, where they are located on plots for future development. This applies to the majority of the area to the north.
- However, to the south, a new south facing public space is proposed which has the potential to become an important focus for this part of Hackney Wick.
- The panel think this space would benefit from further thought, for example to relate its design more closely to the station architecture, and create a stronger civic presence.



Materials and Construction

- Delivering the detailed quality of the architecture promised by the planning application drawings will be key to the success of the scheme.
- Conditions relating to the provision of detailed information and sample panels describing the quality of materials and construction should be used and thoroughly enforced to ensure that the quality of the architecture is delivered.

Next steps

• The Quality Review Panel supports the planning application for Hackney Wick Station for approval, and looks forward to seeing it built.
