# Note on process

### 3. Planning authority's views

The Stratford City outline planning permission sets the parameters for development of the Moxy Hotel site, and the planning application complies with this in terms of height and floor area. LLDC planning officers would welcome the Quality Review Panel's views on whether the amended scheme addresses previous concerns about the quality of the architecture and hotel accommodation.

## 4. Quality Review Panel's views

# Summary

The Quality Review Panel supports the revised planning application for the Moxy Hotel. The façade designs that have been developed to clad the innovative cross laminated timber (CLT) construction are both fun and sophisticated. A convincing case has also now been made for the relatively minimal hotel rooms – which are complemented by generous public areas for a range of uses. More detailed comments on architectural expression, quality of accommodation and sustainability are provided below.

#### Architectural expression

- The panel thinks that the architecture of the Moxy Hotel is successful, both in expressing the CLT construction, and creating a high quality addition to the environment of Stratford Town Centre.
- Elements of the building to be constructed in-situ are clad in pre-cast concrete, whilst elegantly proportioned cladding panels are used to express the modular CLT construction.
- Windows are designed both to achieve the best possible outlook for hotel rooms, and add vibrancy to the scheme through sophisticated use of colour.



For example, windows facing the residential development to the south of
the site are angled to provide longer distance views across the railway
tracks. Coloured cladding panels to the blank sides of these oriel windows
provide a lively element to the architecture that seems appropriate to the
building's use.

### Quality of accommodation

- The Moxy Hotel is primarily intended to serve business travellers, with relatively minimal bedrooms, to maintain value for money.
- However generous public areas are provided at ground floor, including a library, waiting area, bar and lounge. This will both enhance the experience of staying at the hotel, and bring life and activity to the street frontage.
- Where bedrooms face onto the narrow internal courtyard, the plans have been revised to provide angled windows that will minimise overlooking, as well as adding character and colour to the internal elevations.
- The panel also welcomes the proposal to use the blank party wall of the neighbouring student accommodation as a canvas for art installations.

# Sustainability

- The proposed use of CLT construction is welcome, in terms of its low embodied energy and use of renewable materials.
- However, the risk of off-gassing from formaldehyde in the resins used in CLT construction will need to be addressed.
- The panel understands that the scheme will target LEED platinum, and would encourage the planning authority to secure this through use of planning conditions.
- The ecological value of roofs should also be maximised, avoiding the use of sedum for extensive green roofs, since sedum does little to support indigenous wildlife.

# Next steps

The panel supports the planning application for the Moxy Hotel and looks forward to seeing it built.
